SERVICES

ORIGINS

ICET was founded in 1956 in Milan, in the Barona district, thanks to the initiative of a young law graduate, animated by a great passion for cinema: Francesco Corti.

To him we owe the creation of the first cinema theatres in Northern Italy.

Corti began working for the cinema industry and for RAI, overcoming quite a number of obstacles due to the impact of this new activity,

until then monopolised by Cinecittà in Rome, on the Milanese territory.

In 1958 the decisive turning point: 'Carosello' was born and immediately became a cultural phenomenon, representing up to 70% of ICET's entire production.

The needs of an ever-expanding market prompted Dr. Corti to join forces with other entrepreneurs, including Commendator De Paolis of Rome, and to organise a real Milanese 'Cinecittà', with spaces and facilities capable of hosting the most successful productions of its time and coping with the development of the television sector.

This was the birth of Icet-De Paolis, the founder in Cologno Monzese of 'Cinelandia', which grouped together film studios, recording studios and areas dedicated to animation as well as a series of services dedicated to the sector.

EVOLUTION

Cinelandia's activities continued until 1983, when the new horizons of private television and in particular of Mediaset (then Fininvest) opened up. It acquired the entire area owned by ICET and thereby developed Italy's most important private television group in Milan 2.

ICET was then able to build new television studios both in Cologno Monzese and in the neighbouring town of Brugherio; the new studios were later sold to QVC.

Today ICET Studios is a dynamic reality, oriented towards the management of its own studios and the creation of scenic installations for cinema, television and advertising.

Thanks to the work of Dr Corti's sons, Gianmario and Guido, it has also been successful with new professional activities, in business areas and in the events and trade fair sectors.

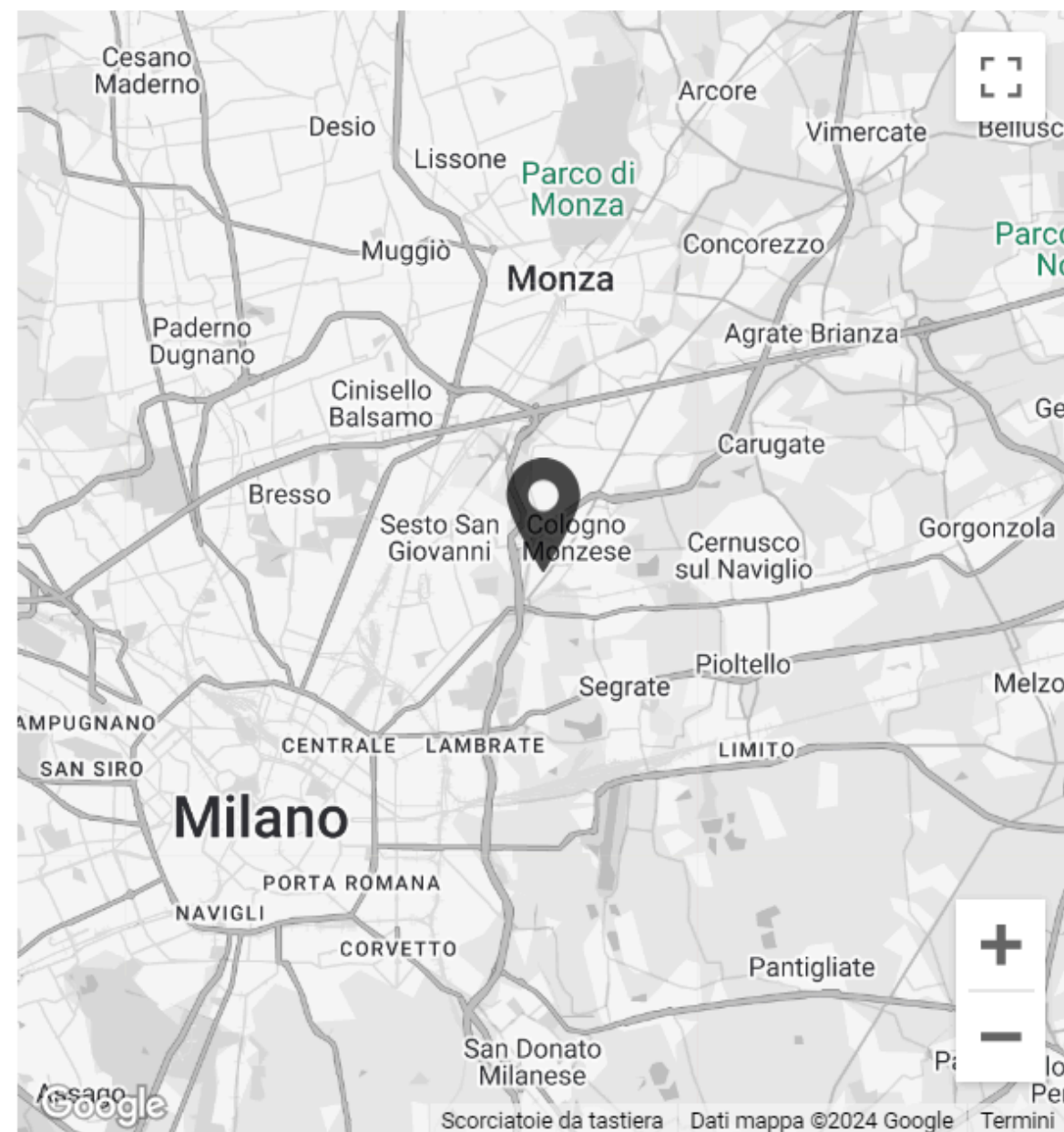
